### PR1/04/19 Apologies for Absence

Apologies for absence were received from Cllr Mrs Anderton, Cllr Dougherty and Cllr F Potts in respect of this meeting.

### PR2/04/19 Declarations of Interest

Cllr Connell declared a personal interest in relation to any agenda items that relates to Cumbria County Council and Eden District Council.

### PR3/04/19 Actions from the Previous Minutes

There were no outstanding actions from the previous minutes in respect of this meeting. The Clerk noted that the growth of willows on the river bank had not been included on the agenda of the Planning and General Purpose Committee as requested. This would be included on the next agenda.

### PR4/04/19 Chairman's Report

### PR5/04/19 New Fair Licence

The Clerk advised that the lease for Fair Hill does not align with the licences for the other sites used during the Fair. It was therefore **RECOMMENDED** that the time vehicles were permitted on the site on Thursday morning be changed from 6am to 4am. This will align the lease with the licences of the other sites. It was also **RECOMMENDED** that the cost of the lease be increased by 5% in line with the same increase in this year's Precept.

### PR6/04/19 Heritage Action Zone Project: Grant Applications

The Clerk advised that grant application packs had recently been received from the Heritage Action Zone project for the external refurbishment of the High and Low Crosses, The cloisters and the front of Market Arcade / Public Hall. The Property and Services Manager is focussing on the High and Low Crosses initially.

Cllr Connell advised that a hole made near Jubilee Car Park before Christmas by Cumbria County Council Highways Department to assist with drainage issues would be repaired before Horse Fair. Cllr Hayes advised that Kirkby Stephen Library had changed to an automated system.
