F1/07/24 Apologies for Absence

F2/07/24 Declarations of Interest

There were no declarations of interest to report.

F3/07/24 Actions from the Previous Minutes

• Alternative Investment Options

The Council currently has two accounts with Barclays and a savings account with the Cumberland Building Society, which holds the majority of the Council's general reserves. As the Cumberland's current interest rate is 4.1%, a large chunk of the precept money has been moved into the savings account, to take advantage of the favourable interest rate.

The Clerk reported that she had carried out some research on alternative investment options and unless we were to move money into a fixed term account, the best option for Council's is the Public Sector Deposit Fund. This is not a bank, but a portfolio management fund, specifically for Councils and although it currently yields a good interest rate of 5.2%, it is not a guaranteed investment.

It was agreed to keep things as they are for the moment, but monitor the situation.

F4/07/24 Chairman's Report

There is no Chair's report in respect of this meeting.

F5/07/24 Management Accounts

The Chair presented the Management Accounts for June 2024. It was noted that the gas and electric contracts have been renewed with Westmorland & Furness Council and the cost has decreased substantially from last year. The Clerk reported that the increased costs for the Market Arcade toilets was due to additional cleaning during Horse Fair, but this was funded by the grant given by ISOR CIC.

The Management Accounts for June 2024 were accepted and **RECOMMENDED** to Full Council.
