### P6/07/19 Chairman's report

There was no Chairman's Report in respect of this meeting.

### P7/07/19 Eden District Council: Scheme of Delegation and Planning Code of Conduct

Councillors noted correspondence received from Eden District Council with regard to constitutional changes and the delegation of Council functions to Council officers.

### P8/07/19 Appleby Junior Football Club: Proposed Dog Exclusion from the Football Pitch

Cllr Connell advised that the field had originally been owned by the Lowthers, after it had changed ownership a number of times it was purchased by the Borough Council for £1,000 in 1944 as a public park. It would appear that there are no covenants governing its use and the land is now part of "Fields in Trust" with Eden District Council as Trustees. Cllr Miss Hutchinson said that she had noted, on beaches for example, when dogs were excluded on a seasonal basis. Cllr Stephenson said that without appropriate enforcement any change to the existing order would be a waste of time and whilst he agreed that dog fouling should be removed he also stated that there were a number of responsible elderly dog walkers who took great pleasure in exercising their dogs on the field. It was **RECOMMENDED** that the Council should write a letter to the Appleby Junior Football offering the Council's support in asking Eden District Council to undertake a public consultation as to whether dogs should be excluded from the football pitch or not.


**P10/07/19 Date of the Next Meeting**
